

The recovery time between two climatic shocks increasingly reduced


Humanitarian action is an important component of political governance



Vulnerabilities to climate change in West Africa

Basic indications

Three factors determine the vulnerability of a system to climate change:

- ☐ the nature of climate changes to which it is exposed;
- ☐ its sensitivity to climate;
- ☐ its ability to adapt to changing climatic conditions

Overview of the vulnerability of West African climate change

The vulnerability of West African climate change include:

Poverty: it is the factor that most limits the ability to adapt to climate change. Countries and peoples of West Africa did not have the resources to develop and implement various options to adapt to climate change;

Sensitivity of key economic sectors to climate: agriculture is mainly rain-fed and strong dependence of populations to natural resources that are fragile (desertification).

Deficit of scientific knowledge: scientific knowledge of the potential effects of climate change is necessary for the implementation of relevant options of adaptation

Access to information and technology: access to information and technologies enhance the adaptive capacity of communities;


Poor governance: a governance that sustains or maintains poverty creates vulnerability to climate change

Vulnerabilities at the community level

At the community level, vulnerability factors include:

- poverty
- sources of income that are not diversified and climate-sensitive;
- a high dependence on natural resources;
- limited access to basic services;
- geographical isolation;
- a low level of education among the population;

Pillars of climate change response



Scientific research directions for decision support in West Africa

Lines of research could be:

- the rate and magnitude of climate change;
- impacts and vulnerabilities related to climate change;
- the social and economic consequences of climate change;
- development of scenarios for increasing resilience to climate change;
- methodologies for taking into account considerations related to climate change into development policies;

Technological developments and innovations

Increase access to technology for solutions to climate risks, especially at local level (agriculture, water resources, livestock, housing, ...)

Governance

Ensure that an indicator of good governance is taken into account considerations related to climate change in development programs

Example of scenarios to promote dialogue Case of food security

To contribute to the debate on the future of food security in West Africa, our institute uses three scenarios of climate change and food security. A scenario is a description of a possible future, among many others.

The climate change scenarios:

Scenario S1: a radical and negative climate change at regional and local level

Scenario S2: a changing climate characterized by an increase in temperature, frequency and intensity of climatic shocks

Scenario S3: a changing climate that is characterized by a return to favorable climatic conditions




ClimProspect model
