Good performance and inclusiveness of poor people in cooperatives and other producer organizations: a possible match?

A research study on nine POs in different regions, carried out by the Department of Economics of Roma Tre University and the Food and Agriculture Organization of the United Nations (FAO), suggests that this is possible. The research shows that strategies promoting social opportunities can expand people's agency and capabilities, thus encouraging the development of an informed, motivated, skilled and active membership.

Breaking the cycle of unsustainable food systems, hunger, and debt

As 2023 begins, the world is on the brink of a devastating debt crisis. Following a decade of steadily rising debt levels, public finances in low-income countries have been strained by the COVID-19 pandemic and the economic disruptions ensuing from the Ukraine war – particularly sky-high import costs for food, fertilizer, and energy, and rapidly-rising interest rates. Although food prices have come down from Spring 2022 peaks, debt servicing costs are projected to rise further this year and next, and the worst impacts are surely still to come. About 60% of low-income countries, and 30% of middle-income countries, are now considered at high risk of (or already in) debt distress.

The Mesoamerica Without Hunger Programme (MSH) is a regional cooperation initiative, with a total budget of US\$15 million and an eight-year cycle (2015-2022), funded by the Mexican Agency for International Development Cooperation (AMEXCID) and implemented by FAO in nine Mesoamerican countries: Belize, Costa Rica, Colombia, El Salvador, Honduras, Guatemala, Nicaragua, Panama and the Dominican Republic.

Map of Organic Fairs

The Organic Fairs Map is a search tool, idealized by Idec (Brazilian Consumer Defense Institute), with the objective of stimulating healthy and sustainable food throughout Brazil and showing that organic and agroecological products can be more accessible to consumers.

The Map aims to shorten the path of the consumer to the producer to expand the access to healthy food, produced without pesticides. Another concern of the platform is to value fairer trade relations and initiatives that seek to minimize the environmental impacts caused by food production.





Latest from Near East and North Africa

Near East and North Africa – Regional Overview of Food Security and Nutrition 2022

This year's report presents evidence that Arab States face significant challenges in achieving Sustainable Development Goal 2 targets related to hunger, food security, and nutrition, as undernourishment, moderate or severe food insecurity, and malnourishment are increasing. Child wasting and overweight are higher, and adult obesity is double the global average. LDCs and conflict-affected countries suffer from even more severe hunger and malnutrition, including child stunting, wasting, and women's anaemia. The report also provides the first assessment of the cost and affordability of a healthy diet since the outbreak of the COV-ID-19 pandemic, which shows a growing trend in the price of nutritious diets in recent years and that more than half the Arab population cannot afford a healthy diet.
